## 1 - Invitation

The competition, organized by Canottieri Luino rowing club, will develop on a general layout of **8 kilometres**, next to the Lombard coast of Lake Maggiore between Luino and Maccagno. The course, as shown on the attached “A”, will be delimited by boas. Then regatta field and the layout can be changed on unquestionable opinion of the Organisation Committee in relation to the weather conditions or direction of competent Authority.

The regatta will take place **Sunday 3<sup>rd</sup> August 2008**, with departure of the first trial at **09,30 a.m.** The trials will follow in sequence as shown on the attached “B”.

Are allowed to participate to the Regatta male and female rowers belonging to the categories “**Junior**” minimum age-limit 18 years old, “**Senior**” and “**Master**”. The coxswain is admitted indifferently of both sex. Every crew must specify, at registration time, in which category want to race.

All participants (included the coxswains) will necessarily owe to be enrolled for Rowing Clubs regularly affiliated to the Italian Rowing Federation or to foreign Federation affiliated to FISA for the year 2008.

It is admitted the share of mixed crews. Each rower is admitted to participate in one trial only. The regatta doesn't attribute useful score to the goals of the national classifications.

## 2 - Boats

Only 4 rowers boat type “Coastal Rowing” equipped with sculling oars (Yoles de mer – type FISA 4X+) are allowed to take part to the competition. Boats must fulfil the requisite requested by FISA and by the rules related to the coastal rowing which are deemed to be here fully incorporated. Every boat will necessary must be provided with n° 4 life jackets (one for every rower) lodged on the boat and an afloat towing line, anchored to bow, of mt. 20 of length. The coxswain, during the regatta, will necessarily wear his life jacket. If necessary the boats will be provided, free of charge, by the Organisation Committee.

## 3 – Registration

The registration expires on **Tuesday 29<sup>th</sup> July at 24,00 hrs.**

The original copy of the registration form (attached “C”), duly completed and signed by crew or Rowing Club representative, will be handed in to Committee at accreditation time. The registration fee has fixed in € 5,00 (five Euro) for each rower included coxswains and must be paid at accreditation time.

#### **4 – Accreditation**

The accreditation and the definitive registration will be effected by the representatives of the Rowing Clubs **from 8.00 to 8,30 a.m.** on **Sunday 3<sup>rd</sup> August 2008** at A.V.A.V. Yachting Club – Viale Dante Alighieri 6, Luino – Italy.

The possible withdrawal of one or more crews and/or variations of rowers and coxswain will be annotated during the accreditation time. The withdrawn crew which do not exhibit a medical certificate will be penalized of 25,00 €uro for each rower according to C.d.R. (Italian Rowing Code)

#### **5 - Crews Briefing**

The briefing pre-regatta will be held, by Committee of Regatta and President of Jury, **at 8,30 a.m.** at A.V.A.V. Yachting Club. During this briefing detailed information, included safety information, and instructions will be provided to crews members. The attendance is compulsory.

#### **6 – Documents of identification**

For all participants document of identity in progress of validity.

Rowing Clubs Representatives and/or Crew Leaders are responsible for medical eligibility of their rowers towards Organisation Committee and Italian Rowing Federation.

#### **7 – Uniform**

Uniform must correspond to the official one deposited for every represented Society and must be the same for the whole crew, also in case the rowers belong to two or more rowing clubs.

#### **8 – Awards**

For each trial, according to the order of arrival, will be given the following prizes:

- Cup and gold-plated medal for the winner
- Silver-plated medal for the second
- Bronze medal for the third

The Rowing Club classified first of the **overall placing**, developed on the base of general results, will win the **Trophy Vicor Cup 2008**.

The first three Society classified in the overall placing will also be given **purchase vouchers** respectively of **500,00 €uro** for the first standing **300,00 €uro** for the second and **200,00 €uro** for the third. All rowers participants will receive a **T-shirt** of Coastal Rowing Center Luino. For more information please refer to attached **“D”**.

#### **9 – Assistance**

For the whole duration of the Regatta services of medical assistance and technical aid of boat-support shall be provided and guaranteed.

## **10 – Logistic**

Logistic details (as like boats, launching boats area, parking, services, and so on) will be communicated later via internet and at the moment of accreditation. Bar and restaurant will be available by start/finish area. Information on hotels and accommodations can be find at following addresses:
